Please note that euro 27.230,00 is the net price of the oil.
As explained in the notes of the quote and in my email below, there is an additional cost for the pumping service and transport to La Spezia.
As you can see, the pumping service is 0.06 EUR/LT (so total euro 420.00).
Dedicated transport to La Spezia is euro 380.00.
Moreover, oil excise duties have to be considered as additional charges on top of the net price. Oil excise duties are euro 0.69/LT + euro 0.13/LT.

I've now highlighted in yellow colour these additional costs in the quote attached.
